### Early Vaccine Recipient Involved in the Vaccine Rollout Campaign Speaks Out – Reveals He Suffered Adverse Reaction – Exposes How Corporate America Colluded with the Government to Push Mandate

According to Cunningham, he developed adverse reactions days after he received the Covid vaccine, along with six other healthcare at the time.

He also claimed that Corporate America colluded with the government to push the experimental Covid vaccine.

"This is why I left the propaganda machine. I'm ashamed I didn't realize sooner even with a M.S. in Emergency Management disaster preparedness. The government has and will violate civil liberties in the name of safety. PsyOps," he <u>wrote</u>.

"Even though I've been on the "right" side of the pandemic narrative for over two years, I wrestle with how many families were destroyed or broken up by the MSM and Gov narrative. I'm ashamed I was involved in that narrative in any way," he <u>said</u>.

I got the COVID vaccine before most could as healthcare provider and emergency manager implementing many of the policies of the "covidians". Days after I was transported to thehospital with cardiac issue. Today I'm in heart failure.

From working out twice a day and lean to my heart jumping to 160 BPM sitting still. My endocrine system is now gone and my weight gain is 70+ pounds.

Here goes my story..... First, let me give you a bit of background. I have a Masters's Degree in Emergency Service Management. I happened to specifically study a pandemic and when the government would violate civil liberties in the name of safety.

In Corporate America, I worked as an Emergency Services Manager for a fully integrated steel plant. The same facility [Donald Trump] visited and helped re-open in 2018.

This is where it gets interesting... How are Government, Big Tech, and Corporate America connected as it relates to mandates? Many states have "fusion" ordisaster response centers. These centers have a "business emergency operations" componentto them for the private sector.

The goal of these fusion centers. Have liaisons with all the major businesses and keep them "in the know" with the actions of the government and get buy-into support initiatives. Seems harmless until COVID happened.

When the Government imposed many of the mandates, they KNEW they were mere "guidance," but if they could get big tech, major media, and Corporate America on boardthey could have these entities implement "administrative" or workplace policies.

How do I know... I was shamefully involved in the process. In my gut, it didn't feel right, but I made videos and marketing materials supporting others to get vaccinated. I interacted withthese fusion centers, and I helped implement many of the initial mandates.

Because I had a healthcare provider license and was on the "team" I was one of the first toget vaccinated... and that's when it all took a turn for the worst. For those who judge today atthe time, there were no horror stories. I was one of the first.

Days later, after my vaccine, my heart was beating out of my chest, and then I thought I wasgoing to die. I didn't know where I was. I was saying my last prayers. At the time, I was ingreat shape, working out twice a day. Off to the hospital, I went.

Let's remember I managed an Emg Srvc department, including an ambulance division. When I got to the hospital I was told 6 other healthcare providers had a similar reaction tomine but all felt better after some time and I too felt better in a few hours.

At this time, only healthcare providers could get the vaccination.... not the general public. I thought I was going to be "OK" so I got a few days of rest and "shook it off."

All was not OK. As days went on, I would be sitting at a desk, and my resting HR would jump up to 140 – 160 BPM. I was not doing any physical activity. I was afraid to say anything because I didn't want to lose my job due to health issues. I ignored it.

"Everyone" wanted the vaccine at this time. I often wonder if the staggered rollout making the "health care providers" seem like they are elite to get it first was by design to create a "Fear of Missing Out" with the remaining population.

These "fusion centers" continued to push and work with Corporate America to push the vaccination and give them "elite access" to vaccination clinics. These centers include local, federal, and state law enforcement.

In fact, I was involved in the process of getting the CEO and senior executives of a Fortune 100 company early access to the vaccination. They flew to our location so they could get it because it wasn't available in other locations.

As time went on my health was getting worse... I was gaining weight at a rapid pace and I did not feel great. I live in the deep blue state of Illinois and the governor of my state has some ofthe most severe mandates. PS we're still in a disaster declaration.

What made me decide to stand up and fight back after all of this? It wasn't my deteriorating health it was my children. My son has autism and schools got to violate his services in thename of "COVID"

From a Beach in Flordia, I started a local non-profit, Speak for Students. To goal was to advocate for kids and to stop the mandates. It was from this initiative I met [Thomas DeVore] and [John Ruhlin]. I still ignored my condition.

That's what I did.... I fought for my children and other's children to ensure they could have the free choice to mask or not mask, to vaccinate or not vaccinate. I helped my local county board pass a "mask and vaccine choice" resolution. I still ignored mycondition.

After our success, JB Pritzker decided to put the mandates back in play at the request of the [Chicago Teachers Union] and others. I wasn't having it... I saw how his emergency management staff was colluding with schools, local health departments, and Corporate America.

By this time, the company I workedfor had shifted their messaging from the #BestofBoth to the #BestforAll because they wanted to close the facility that [Donald Trump] helped re-open. Why? Because "Steel Making" is not "Green," and sacrificed PEOPLE for PROFITS.

ாt's a big number," says former Utah Jazz player John Stockton.

Former NBA player John Stockton claimed he knows "hundreds" if not "thousands" of professional athletes who have died as a result of taking the experimental COVID-19 injection.

Stockton, former point/guard for the Utah Jazz, joined the "Sideline Sanity" podcast for an interview last month to revise an earlier claim he made that over a hundred professional athletes had "dropped dead" due to the vaccine.

Heart inflammation has become so common in vaccinated athletes that they're now being <u>screened for COVID vaccine adverse reactions</u> in many cases.



## 16-Year-Old Basketball Player Suffers Stroke While in School

On Tuesday night, a 16-year-old Odessa-Montour girls' hoops standout suffered a stroke while in school.

Keyonna Garrison, an Odessa-Montour junior, had a stroke on January 5 and was hospitalized at Strong Memorial Hospital in Rochester after being treated at Guthrie Corning Hospital, Star Gazette **reported**.

According to a <u>fundraising campaign</u> created to help the family with medical expenses, Garrison had a blocked vertebral artery, causing her to have a stroke.

She had been in the intensive care unit (ICU) for quite some time, but after undergoing numerous tests and treatments, she was finally removed.

"Keyonna is still undergoing neurological tests to find a path forward and to repair the issue as well as physical therapy to recover motor skills. She is on the road to recovery but it will be a long and emotional journey," an entry in the fundraising campaign reads.

#### Star Gazette reported:

Keyonna, 16, was discharged from Strong on Tuesday night, coach Gavich said. Her Grizzlies teammates fell by a 54-34 score to Edison earlier in the evening in Elmira Heights to drop to 6-4.

Before the national anthem, those in the gym responded to a request from Edison athletic director/dean of students Mike Bennett with an extended ovation in support of Garrison. Gavich said later Garrison received encouraging news Tuesday when she learned surgery won't be required to repair a damaged blood vessel.

As of late Tuesday night, the GoFundMe for Keyonna had raised more than \$14,000. Edison's girls basketball program presented a donation envelope to Gavich.

"They're still hopeful for a full recovery and she's back playing sports as a senior," Gavich said. "That's as good as we can hope for."

Garrison became ill during gym class Thursday morning. Gina Gavich, Greg's daughter, noticed her on the gymnasium floor and thought Garrison possibly twisted an ankle. She told her father and Greg immediately went to check on her. He received no response from Garrison as nurses treated her.

According to her GoFundMe page, Garrison will undergo physical therapy to improve her motor skills. There was no impact to her cognitive skills, Greg said.

### Mother Blames Covid Vaccine and Government After Son Develops Blood Clots in His Brain 9 Days Following Vaccine – Son Now Has More Clots and a Damaged Heart

"[The vaccine] has altered his life path forever. He is lucky to be alive today but his life will never be the same. In 2021, everyone who talked about this had their social media pages frozen. We need truth in reporting these events. It is not rare & it happened to us," she continued.

Everest Romney felt his neck was swelling. In the following days, he suffered from severe headaches.

Mrs. Romeny told <u>ABC4</u> that the pediatrician first blamed a torn neck muscle for her child's symptoms, despite her insistence that it was something more serious.

Mrs. Romney said that if she had listened and followed the doctors' advice, her son "would not be alive today."

"If I had kept quiet and listened to the [doctors] at first, Everest would not be alive today. While they admit now that they were wrong in the beginning, the resistance to even checking him for the blood clots was immense. Had we not persevered against them, there would be a very different ending to this story," she said.

On Tuesday, January 3, 2023, Mrs. Romney gave an update about Everest.


She said that Everest had developed another blood clot in a deep vein in his right leg, and doctors had confirmed that his heart was still damaged due to the vaccine.

"Just left the Emergency Room TODAY. Everest has another blood clot, a deep vein in his right leg & they have confirmed his heart is still damaged. Referral to a cardiologist – more to come about his heart as it seems the damage from the inflammation may be permanent. Never mind the [effects] of the traumatic brain injury he still deals with on a daily basis," Mrs. Romney wrote.

Mrs. Romney went on to blame the mRNA Covid vaccine and the Biden administration for suppressing information about the vaccine's risks.

"Thanks Covid vaccine, thanks to the US government. My former 6'9" basketball player is no longer a basketball player and he is back on blood thinners starting tonight. So glad I was doing "the right thing" and protecting him from Covid, bummer that the lies about that have altered his life forever and almost killed him. Covid never even made him sick," she said.

"He is at St Mark's Hospital tonight, with multiple pulmonary emboli. Tomorrow – hematologist & cardiologist. Hopefully home soon," Mrs. Romney wrote.

According to Mrs. Romney, doctors don't know how to stop the effects caused by the vaccine.

"We know the cause, it's just that the Covid vaccine is such an unknown that the [doctors] don't know how to stop the [effects] once they've put everything in motion. It's more about managing the symptoms because the damage can't be undone," she responded in one of her posts.

Mrs. Romney described her son as a tough kid and a good man.

To respect the family's privacy, The Gateway Pundit has decided not to publish the child's name.



### Former Alabama Crimson Tide Running Back Ahmaad Galloway Dies Suddenly At Age 42

Alabama football nation and Compton-Drew Middle School in St. Louis, Missouri went into mourning with the sudden passing of former Crimson Tide football star Ahmaad Galloway last Monday. Galloway was just 42 years old and a teacher at the middle school.

The eighth graders at Compton-Drew Middle School in St. Louis, Missouri are in mourning today. They have shut the door of a popular teacher's classroom. It's out of respect for their English teacher, a teacher they loved so much.

Former Bama running back Ahmaad Galloway has died. School principal Susan Reid says that Galloway, an eighth-grade English

teacher, was found dead on Monday at his St. Louis apartment during a welfare check.

"Ahmaad was always on time, very responsible, so we knew something might be wrong," Reid said. "There wasn't anything disrupted at Ahmaad's apartment, so we are thinking that it could have been a medical issue."

Galloway was a quiet, humble man who let his talking take place on the football field. A bruising running back out of Millington, Tennessee, Galloway played for the Crimson Tide from 1999 to 2002.

"Ahmaad was always quiet and humble," his sister Kimberly Slaughter tells me. "My brother loved football growing up and later loved his children Austin and Aubrey."

An official cause of death may not be known for a few days. "The medical examiner is working to find out how Ahmaad died," school principal Reid says from St. Louis. "The family is coming together from different parts of the country before deciding on funeral arrangements."

Galloway's eighth-grade students are gathering today through tears to honor their first-year teacher. While they will keep Galloway's class door shut out of respect, they will make signs and banners, hoping that doing so helps ease their pain. The school crisis team has sprung into action. Students at Compton-Drewe ILC Middle School are receiving counseling.

Before moving into the teaching profession, Galloway enjoyed a stellar career at the University of Alabama. He ended up <u>rushing</u> for 1,830 yards and seventeen touchdowns during his four years at the Capstone.

The Denver Broncos <u>selected</u> Galloway in the seventh round of the 2003 NFL Draft, but sadly he never played a down in the league. He

Galloway's life may have been cut too short, but it was still a life welllived and full of accomplishments. Roll Tide forever, Ahmaad.

## Woman with No History of Heart Issues Dies Suddenly of Cardiac Arrest, Friend Calls on Community for Help

A Las Vegas woman has started a fundraising campaign for the family of a friend who died suddenly Jan. 8.

Michele Morgan told <u>KLAS-TV</u> that her friend, Alicia Groeblinghoff, went into cardiac arrest while working out at a gym.

Groeblinghoff, died the next day. She was 46, according to her obituary.

Morgan told KLAS her friend had no history of heart problems before she "suddenly, without warning, collapsed at the gym and suffered a massive cardiac arrest."

Morgan has set up a <u>GoFundMe</u> to raise funds to help pay Groeblinghoff's medical bills, which she said "are going to be astronomical" because she had to be transported to the hospital and placed on life support.

The bills are going to be "more than the family can handle," she wrote.

Groeblinghoff had two children, 15 and 9, and the financial assistance will also help with their college, Morgan said.

As of Tuesday afternoon, the fundraiser had taken in about \$38,000 toward its goal of \$250,000.

Morgan described Groeblinghoff as "my friend and business partner for 30 years."

"She was such an amazing soul, with a contagious smile, and kindness that we do not see every day," she wrote on GoFundMe. "Everyone who was fortunate enough to have their path come in contact with Alicia's, immediately loved her."

During the week before her death, two Las Vegas-area teens also died suddenly.

Jordan Brister was pronounced dead after collapsing in a school restroom Jan. 3.

A <u>GoFundMe</u> appeal created Jan. 7 said, "Jordan Tyler Brister suddenly and unexpectedly suffered cardiac arrest while at school with no explanation as to why. Jordan was a senior in high school who planned to join the military after graduating."

Another Las Vegas teen, 16-year-old Ashari Hughes, died suddenly Jan. 5 after suffering a "medical emergency" while playing in a flag football game.

The Clark County Coroner later <u>ruled</u> Hughes' death was due to a congenital heart defect related to an "anomalous origin of the right coronary artery from left coronary sinus of Valsalva," KLAS reported.



## Second High School Student Dies Suddenly Within a Week in Las Vegas After Suffering from Cardiac Arrest

A senior high school student at Amplus Academy in Las Vegas was found unresponsive in the school bathroom last week after suffering cardiac arrest for unknown reasons, according to his family.

Jordan Brister, 18, passed away on Sunday "suddenly and unexpectedly" after suffering a cardiac arrest on January 3 after gym class "with no explanation as to why," according to a <u>fundraising</u> <u>campaign</u>.

According to Brister's father, Conrad Brister, it may took 25 minutes before he was found. He added, that during that time, Jordan's heart stopped.

In a statement, the public charter school stated its personnel rendered "immediate medical assistance" to Brister until paramedics arrived.

Jordan was admitted in ICU at Southern Hills Hospital and was pronounced dead on Sunday.

"It is with deep sadness and sympathy that we announce the passing of one of our Senior High School students, Jordan Brister," Amplus Academy wrote on its Facebook page.

"The Amplus community sends our love and condolences to the Brister family as well as to all of Jordan's family, friends and acquaintances," the post continued.

The Clark County Coroner's Office told **KSNV** that they are still looking into the exact cause of Jordan's death.

Tributes poured in following the news of Jordan's passing.

Jordan Brister's death comes after another high school student died in Las Vegas within a week.

On Thursday night, a sophomore high school student in Las Vegas, Nevada, died suddenly while playing flag football.

Ashari Hughes, a 16-year-old player for Desert Oasis High School, collapsed suddenly after the team's home game against Valley High School on Thursday night because of a "medical emergency."

The Clark County Coroner's office has not yet released Hughes' cause of death.

## Young Priest "My Heart Issues Began When I Got Vaccinated"

In a 25-minute video, Father Edward Looney detailed his 23 month journey with tachycardia since being vaccinated.

"And in fact, hospitals told us if we were not vaccinate we would not be able to visit people in the hospitals. We were told we couldn't go to nursing homes if we didn't get vaccinate. If we didn't get vaccinated, there...there...where it almost seemed like, for the sake of your job...and you see this today on job resumes and applications...."

## ABC News Journalist Breaks Her Silence, Reveals She Developed Heart Condition Due to Covid Vaccine

Dr. Phelps responded to Roussos' tweet, "I hoped my submission to the parliamentary inquiry would spark the conversations we need to have about long covid and vaccine injury. I hope we can find answers leading to recovery for you and others."


Professor Kerryn Phelps was an outspoken advocate of mass Covid vaccinations for both adults and kids.



24-Year-Old Flight Attendant at Air Albania Collapses and Dies Suddenly from Heart Attack Shortly After Landing in London By Jim Hoft

A member of the Air Albania cabin crew collapsed and died suddenly last week following a heart attack on a flight from Tirana, Albania to London.

According to the airline, Greta Dyrmishi, who was 24 years old, died suddenly on Wednesday, December 21, due to a heart attack shortly after landing at Stansted Airport in London, England.

"On December 21, after we disembarked all the passengers of the flight to London, one of the members of the cabin crew, Greta Dyrmishi, suffered a heart attack," Air Albania said in a statement.

"Even after all the medical assistance offered at the moment, we still lost him. Air Albania has contacted her family from the first moments and we continue to be by their side in these difficult moments."

"Out of respect for Greta and her family, we decided to share the news with the public at the most appropriate moment. We will always remember Greta as a passionate professional, an excellent colleague and a very good friend to all of us."

"With the belief that today she is among the mercy of God, Air Albania will continue to stand by her family," the post concluded.

Following reports that a woman was in critical condition, the East of England Ambulance Service NHS Trust confirmed that a total of six emergency vehicles were dispatched to the scene: two ambulances, a hazardous area response team vehicle, an ambulance officer vehicle, and the Essex and Herts Air Ambulance. Officers from the Essex Police Department were also present, Bishop Stortford <u>reported</u>.

"The Indie was told the aircraft touched down at around 1 pm as scheduled and after efforts to save her life at Stansted, the ambulance service took Ms Dyrmishi to Princess Alexandra Hospital in Harlow," the outlet added.





Dr. McCullough commended the work of the medical staff tending to Hamlin on the field and optimistically suggested Hamlin "can have neurological recovery" thanks to their help.

Getting to what may have caused the incident, Dr. McCullough noted the leading concern is "vaccine-induced myocarditis, if indeed he's taken the vaccine."

He also said the doctors working on Hamlin "have a public health obligation to tell us if he's taken the vaccine."

Later, Dr. McCullough told Tucker, "The FDA says the vaccines cause myocarditis and heart damage. Autopsy studies show it can be and is fatal. The same is true for blood clots and neurologic damage. Our agencies should be protecting the health of Americans and safety is job one. I'm disappointed that they're minimizing it."

On Twitter, Dr. McCullough posted an image from <u>a recent</u> paper showing a sharp increase in deadly cardiac arrests in athletes since January 2021.

## Multiple Young Athletes And Former Athletes Died Suddenly This Past Month

Former Alabama Broncos star running back Ahmaad Galloway died suddenly this week at age 42. Galloway was an eighth-grade English teacher at Compton-Drew Middle School in St. Louis, Missouri. When Galloway did not show up for work, the school contacted authorities. Police conducted a welfare check and found the former football star dead in his apartment. The cause of death has not yet been made public.

Compton-Drew Middle School Principal Susan Reid said she knew something wasn't right.

"Ahmaad was always on time, very responsible, so we knew something might be wrong," Reid told WVTM 13. "There wasn't anything disrupted at Ahmaad's apartment, so we are thinking that it could have been a medical issue."

His passing is just one among a flurry of sudden fatalities in the past year among athletes and former athletes in particular, occurring at relatively young ages. In the majority of deaths, heart failure or circulatory failure is found to be the culprit.

Jordan Brister, 18, died Sunday, Jan. 8, after suffering a cardiac arrest on Jan. 3 during the school day at Amplus Academy in Las Vegas, according to a statement by the school shared by NBC affiliate KSNV. He was found unresponsive in the school bathroom after attending gym class, his family told KSNV.

According to local reports from Campbell County, 17-year-old Max Sorenson died of a "medical event" at his home Monday, December 26. Campbell County Coroner Paul Wallem said that following the medical incident at his home, the high school basketball player was rushed to the Campbell County Memorial Hospital in Gillette, Wyoming.

However, despite efforts from the doctors, he was pronounced deceased.


Mixed Martial Arts (MMA) fighter Victoria 'The Prodigy' Lee has tragically died last week at just 18 years old, of a medical condition which has not yet been revealed to the public.

A 16-year-old girl in Las Vegas has died after "suffering a medical episode during an athletic event according to a message sent to families," reported KSNV, the NBC affiliate in Las Vegas. The student has been identified as 16-year-old Ashari Hughes. The medical emergency occurred Jan. 5 during a flag football game, according to The Las Vegas Review-Journal. The newspaper also reported that Hughes collapsed during her team's home game against Valley High School. She was taken to the hospital and died later that night.


Excess deaths have jumped dramatically in the US (excess deaths being fatalities beyond the yearly average). The majority of excess deaths in the past two years involving people under the age of 65 were not caused by Covid infection. At least 32,000 excess deaths in 2021 have been directly attributed to heart failure and circulation related failures. Circulatory deaths were a major contributor to additional deaths among ages 18 to 44.



The UK has released information indicating a similar spike in excess deaths last year - The highest in 50 years, in fact. UK officials of course deny any connection to vaccine side effects (an often cited concern by the public), and instead claim that heart failure may be the after-effect of covid infection. However, multiple reports and studies show that the covid virus causes no significant damage to the heart and is not a contributor to heart failure, despite rumors spread within the mainstream media.

For example, In March 2021, a group of sports cardiologists reported on nearly 800 professional athletes who had tested positive for Covid-19. Less than 1% of these athletes had abnormal findings on cardiac magnetic resonance scans or stress echocardiography. None of these athletes had cardiovascular trouble when they returned to play.

This means that there is some other cause besides covid which just happens to have started in 2021. Studies do show a direct link between covid vaccination and Myocarditis. This would help to explain the jump in non-covid excess deaths related to heart failure since 2021, but since most studies investigating vaccination side effects do not use unvaccinated people as a control group, there is no hard data on vaccinated versus unvaccinated negative events.



There will certainly be deaths among younger people for a myriad of reasons that are natural, and the cause of death of Ahmaad Galloway and others may be any number of culprits as many medical reports remain unreleased. That said, it is important to note the ongoing and highly suspicious trend of heart damage to people well below the age of commonality and track it carefully.


