Edward Dowd Presents Irrefutable Evidence Vaccine Mandates Killed & Disabled Countless Americans

"Unless we have a new virus that knows you're working, there's no explanation for it."

Back in March 2022, Edward Dowd dropped a bomb using the CDC's own data to show an 84% increase in excess mortality among the millennial cohort, temporally related to the introduction of vaccine mandates from the summer into the fall.

"Starting in the summer into the fall with the mandates and the boosters, there were 61,000 excess millennial deaths. Basically, millennials experienced a Vietnam War in the second half of 2021," he reported. "This is what we call democide, death by government."

Ever since former Blackrock portfolio manager Ed Dowd started making waves with his data, the mainstream media hasn't put much effort into debunking Dowd's argument. Instead, they opted to ignore him.

And since then, he's analyzed data set after data set — maintaining the conclusion that the mRNA COVID-19 injections are leaving behind a trail of destruction, disability, and death. He's summarized his thesis into a compelling book, "Cause Unknown": The Epidemic of Sudden Deaths in 2021 & 2022.

But not everyone has the time to read an entire book.

So Edward Dowd delivered the "elevator pitch."

"What is the most compelling piece of evidence that you have discovered and that you have covered to show that the vaccine is indeed harming people? What is the one or two pieces of data that you think are the most persuasive?" asked conservative pundit Charlie Kirk.

"So, two data sets," replied Mr. Dowd.

1.) The Society of Actuaries Group Life Policy Holder Data

Group Life Insurance is a life insurance policy often offered by large and mid-sized corporations to their employees. In 2016 the Society of Actuaries performed a study looking at the years 2010 through 2013, in which they compared the mortality rates of people on Group Life Insurance policies to the general population. And they found that the Group Life cohort died at about one-third the rate of the general population for each respective age group within working-aged years.

But "that inverted in 2021." Instead, Group Life policyholders (employed with well-paying jobs) suffered 40% excess mortality, whereas the general population experienced 32% excess mortality — an 8% difference.

"I blame the vaccines and mandates," declared Edward Dowd.

2.) The U.S Bureau of Statistics Disability Data

Over three million more unfortunate souls - than two years ago - are now among the U.S. disabled population.



What's interesting is that the trend was overall heading downward in 2020. It wasn't until 2021 that the disability numbers took a significant turn for the worse — increasing by 10%.

"That was a three standard deviation event, which in geekspeak, happens point 0.3% of the time — rapid increase," explained Mr. Dowd.

"Of those 3.2 million people that were added, 1.7 million are employed. When you look at the disability rate increases, employed went up 31%; the general US population went up 9%," reported Edward Dowd.

"And what's even worse is those not in labor force — those are people who could work and are willing to work — their disability rate only went up 4%. Those are the people who got fired for not taking the jab or refused to take the jab and quit."

"So typically speaking, the employed of the country, by the very nature of going to work, aren't as disabled as the general US population. And this has never happened in the history of our country," he attested.

"Those two pieces of data are, for me, a mic drop. That's what I presented to Senator Ron Johnson (R-WI) in December, And that's it. That's all we need to know."

But correlation doesn't necessarily mean causation. "You don't know the vaccine is causing that," many would argue.

Ed Dowd responds to such argument, "Well, so did the virus mutate in 2021 and 2022 to only affect younger age working people, but somehow avoid those who are not employed? That's it. **Unless we have a new virus that knows you're working, there's no explanation for it.**"

So, if the vaccines are killing people, approximately how many people have died because of them?

Edward Dowd has already analyzed the data and documented it on his website. And he found that for every excess death, there are about four additional cases of disabilities.

So according to Mr. Dowd's calculation, if 3.2 million more Americans have become disabled in 2021 and 2022, that means about **800,000 Americans have died due to the COVID injections**.

Report: Babies Breastfed by Mothers Who Took mRNA Vaccines Are Dying

Babies being breastfed by mothers injected with mRNA shots against the Wuhan coronavirus (COVID-19) are dying.

This warning came from Dr. William Makis, a Canadian physician with a triple specialization in radiology, oncology and immunology and the author of over 100 peer-reviewed medical articles. Makis provided two cases of babies who passed away due to being breastfed by mothers fully vaccinated against COVID-19. One case involved a 36-year-old mother from New Mexico, who wrote about how her eight-week-old baby died on July 2021.

"He became very sick with a high fever on June 21, about two weeks after I got the first Pfizer vaccine," she wrote.

"He was treated for two weeks with IV antibiotics for a supposed bacterial infection, however they never found any bacteria."

"After the 14-day course of antibiotics, he was home for one week, but exhibited strange symptoms," she continued, noting how her child had a swollen eyelid, strange rashes and was regularly vomiting.

"I took him back to the hospital on July 15, where he presented with what they called an atypical Kawasaki disease. He passed away shortly thereafter from clots in his severely inflamed arteries," she concluded.

Makis presented another case, that of a five-month old baby who died on March 20, 2021, just three days after the infant's mother received her second dose of <u>Pfizer's mRNA vaccine</u>.

Just one day after the mother was fully vaccinated, the infant instantly developed a rash and "became inconsolable, refusing to eat and developed a fever," Makis wrote. "Baby was brought to ER, blood analysis revealed elevated liver enzymes, was hospitalized but continued to decline and died on March 20, 2021, with a diagnosis of TTP."

Thrombotic thrombocytopenic purpura (TTP) is a disorder characterized by the sudden formation of blood clots in small blood vessels that can block the flow of blood to vital organs like the brain, kidneys and heart.

Doctors have been warning against vaccinating pregnant and breastfeeding mothers since the beginning

Medical experts have been warning governments almost since the beginning of the rollout of COVID-19 vaccines that these jabs should be kept away from pregnant and breastfeeding women <u>over serious concerns about their safety</u>.

One such group – composed 66 doctors, scientists and other clinical practitioners – published its own open letter warning that the safety concerns about COVID-19 vaccinations in pregnancy are too dangerous to ignore.

The group, which includes obstetricians and gynecologists from the U.K., have warned against recent advice from medical organizations in the country about vaccinating pregnant women, claiming that it is in complete contradiction to everything that "it itself and academic institutions have been teaching about evidence-based medicine."

"This advice is that: COVID-19 vaccines are not only safe but strongly recommended for pregnant women," wrote the group in the letter. "Such advice is not grounded in robust data based on ethically conducted research – and anyone who is medically and academically trained should take serious issue with this."

The experts noted how concerned and "deeply disturbed" they are about how best scientific practices are being distorted just to bring a newly developed pharmaceutical product to market.

"We have a collective duty to restore the principles of medical ethics to our practice and to clinical research to protect the most vulnerable groups from harm, and this includes pregnant women and their babies," the group concluded.

Family Of College Student Who Died From COVID-19 Vaccine Sues Biden Administration

The family of a college student who died from heart inflammation caused by Pfizer's COVID-19 vaccine has sued President Joe Biden's administration, alleging officials engaged in "willful misconduct."

U.S. Department of Defense (DOD) officials wrongly promoted COVID-19 vaccination by repeatedly claiming the available vaccines were "safe and effective," relatives of George Watts Jr., the college student, said in the new lawsuit.

That promotion "duped millions of Americans, including Mr. Watts, into being DOD's human subjects in its medical experiment, the largest in modern history," the suit states.

The Public Readiness and Emergency Preparedness Act allows lawsuits against certain people if they have engaged in "willful misconduct" and if that misconduct caused death or serious injury.

COVID-19 vaccines are covered by the act due to a declaration entered during the Trump administration in 2020 after COVID-19 began circulating.

"DOD's conduct and the harm caused as alleged within the four corners of the lawsuit speaks for itself," Ray Flores, a lawyer representing the Watts family, told The Epoch Times via email. "I have no further comment other than to say: My only duty is to advocate for my client. If the DOD conveys a settlement offer, I will see that it's considered."

The suit was filed in U.S. court in Washington.

The Pentagon and the Department of Justice did not respond to requests for comment.

Watts Suddenly Died

Watts was a student at Corning Community College when the school mandated COVID-19 vaccination for in-person classes in 2021. He received one Pfizer dose on Aug. 27, 2021, and a second dose approximately three weeks later.

Watts soon began experiencing a range of symptoms, including tingling in the feet, pain in the heels, numbness in the hands and fingers, blood in his sperm and urine, and sinus pressure, according to family members and health records.

Watts went to the Robert Packer Hospital emergency room on Oct. 12, 2021, due to the symptoms. X-rays showed clear lungs and a normal heart outline.

Watts was sent home with suggestions to follow up with specialists but returned to the emergency room on Oct. 19, 2021, with worsening symptoms despite a week of the antibiotic Augmentin. He was diagnosed with sinusitis and bronchitis.

While speaking to his mother at home on Oct. 27, 2021, Watts suddenly collapsed. Emergency medical personnel rushed to the home but found him unresponsive. He was rushed to the same hospital in an ambulance. He was pronounced deceased at age 24.

According to a doctor at the hospital, citing hospital records and family members, Watts had no past medical history on file that would explain his sudden death, with no known history of substance abuse or obvious signs of substance abuse. His mother described her son as a "healthy young male."

Dr. Robert Stoppacher, a pathologist who performed an autopsy on the body, said that the death was due to "COVID-19 vaccine-related myocarditis." The death certificate listed no other causes. A COVID-19 test returned negative. Dr. Sanjay Verma, based in California, reviewed the documents in the Watts case and said that he believed the death was caused by the COVID-19 vaccination.

Pfizer did not respond to a request for comment.

Watts Took Vaccine Under Pressure

The community college mandate included a 35-day grace period following approval by the U.S. Food and Drug Administration (FDA) of a COVID-19 vaccine.

The Moderna, Pfizer, and Johnson & Johnson vaccines were given emergency use authorization early in the pandemic. The FDA <u>approved</u> the Pfizer shot on Aug. 23, 2021. It was the first COVID-19 vaccine approval. But doses of the approved version of the shot, branded Comirnaty, were not available for months after the approval.

Family of 24-Year-Old Who Died After COVID Vaccine Files Groundbreaking Lawsuit Against Biden Administration

The family of a 24-year-old college student who died after a dose of Pfizer's COVID vaccine is suing the Biden administration's Department of Defense in a groundbreaking action, which could have serious repercussions in the future.

According to a February 2022 <u>WETM-TV</u> report, George Watts Jr., a student a Corning Community College, succumbed to what the coroner called a <u>rare complication of the shot</u>.

"Because he wanted to take his classes in person, George Jr. needed to be fully vaccinated. He scheduled his vaccine appointment and received his first shot in August [2021] and his second in September," WETM reported. "His parents said he chose the Pfizer vaccine because it was recently fully approved by the Food & Drug Administration."

However, the Lockwood native apparently experienced flu-like symptoms, which didn't resolve after his second dose.

"I noticed he was starting to get puffy in the face like a sinus issue. ... He had a cough, and I decided to take him to the emergency room to see what was going on," said George Watts Sr., who said that his son was diagnosed with a sinus infection. After several visits, his parents said, the 24-year-old "began coughing up blood and experienced pain in his feet, hands, and teeth. He also became extremely sensitive to sunlight."

On Oct. 27, 2021, George Jr. collapsed in his room and died; the autopsy said his death was due to "COVID-19 vaccine-related myocarditis."

"I told him that I was going to take him to the emergency room the next day after I got out of work," George Sr. told WETM. "We never made that trip to the emergency room."

Now, he's taking a trip to court.

In a suit filed Wednesday, the family accused U.S. Department of Defense officials of "willful misconduct" by promoting the vaccines as "safe and effective."

The Pentagon, the family alleged in <u>court documents</u>, "caused accelerated production and then pushed out hundreds of millions of vaccines for hundreds of millions of Americans while engaging in a deliberate and calculated mass-deception campaign specifically designed to obfuscate the fact that [Operation Warp Speed's] vaccines weren't licensed 'safe and effective,' were merely experimental, and legally could only be characterized as 'may be effective but could not be pronounced safe."

While calling the vaccines "merely experimental" is perhaps pushing it, the jabs were only able to be used under emergency authorization at the time that Watts Jr. received his inoculations.

A Sandalan Minister

Full Food and Drug Administration approval of the Pfizer/BioNTech and Moderna COVID vaccines didn't come until February 2022, as Johns Hopkins Medicine noted.

"By intentionally blurring the line of the critical distinction between 'licensed' and 'experimental,' DOD duped millions of Americans, including Mr, Watts, into being DOD's human subjects in its medical experiment, the largest in modern history," the lawsuit continued.

"While Mr. Watts cared about the safety of OWS' vaccines, DOD sadly did not."

The Department of Defense is being listed as the defendant in the case because of "its leadership role in Operation Warp Speed ... later renamed the HHS-DOD COVID-19 Countermeasures Acceleration Group."

"Through its officials, the DOD directed and oversaw vaccine development, and directed supply, production, and distribution with HHS to provide support," the lawsuit said.

While families and loved ones <u>can't sue</u> vaccine makers like <u>Pfizer</u> and Moderna over vaccine side effects or subsequent injuries and deaths, the suit claimed that the Public Readiness and Emergency Preparedness Act allows government entities — including the Pentagon — to be sued if they engaged in "willful misconduct."

Now, will the Watts family — and others like them — get their day in court to try and make the case young men and women were used as "human subjects" by forcing them to take vaccines for a disease that posed very little risk to them? That remains to be seen, of course; the suit contains quite loaded language. That said, Watts Jr.'s death wasn't a total one-off.

"Anything that can trigger an inflammatory response can trigger myocarditis. Usually, patients present with chest pain and sometimes shortness of breath," Dr. Liviu Klein, Chief of the Advanced Heart Failure and Transplant at the University of California, San Francisco, said in an interview with WETM.

Referencing a 2022 study published in the Journal of the American Medical Association, which found men under 30 were the most likely candidates to develop myocarditis after receiving a series of <u>mRNA COVID-19 jabs</u>, Klein said the difference between the reaction to the COVID inoculation and other vaccines was significant.

"The number of patients [males under 30] that were diagnosed with myocarditis [was] 50 per million doses of administered, so 50 out of a million," Dr. Klein said. "Just to put it in reference, a normal person [who is vaccinated] would probably be in the range of 10 per million of getting myocarditis."

So, of course, one question is whether this sees the light of day in a court of law. Recent Data Shows 'Stunning Increase' In Serious Harm Reports In Young Healthy Pilots: Army Lt. Col. Theresa Long

It's been <u>a year</u> since four Department of Defense (DOD) whistleblowers found a sudden increase in various diseases in the Defense Medical Epidemiology Database (DMED), which coincided directly with the introduction of COVID-19 vaccinations. Now, new data shows more evi

That's according to Lt. Col.Theresa Long, M.D., MPH, a board-certified aerospace medicine doctor and Army Brigade flight surgeon with specialty training as an aviation mishap investigator and safety officer, who was one of the four whistleblowers. Long's background has uniquely equipped her to recognize what she described as "unusual diagnoses and alarming trends only after the introduction of the COVID-19 vaccinations."

Sharp Increase in Serious Harm Reports in Pilots: Don Data

Long said what she has now found has led her to file yet another whistleblower complaint with Sen. Ron Johnson's (R-Wis.) office. She described this data as "more alarming DMED data" after she "went back into the 'fixed' DMED again to look for signals of harm for Army aviation."

"What I found was a clear signal, that something in 2021 changed the health of service members," Long told The Epoch Times. She said these signals were consistent with those in the Vaccine Adverse Event Reporting System (VAERS) reports. But unlike VAERS reports, DMED data showed spikes in the number of diagnoses "made by a healthcare professional within the DOD on service members."

According to the Military Health System, the DMED provides remote access to a subset of data contained in the Defense Medical Surveillance System (DMSS). The DMSS contains up-to-date and historical data on diseases and medical events (including reportable events) and "is available to authorized users such as U.S. military medical providers, epidemiologists, medical researchers, safety officers or medical operations/ clinical support staff for surveying health conditions in the U.S. military."

"After querying all <u>pilots</u> across the DOD, for all-cause morbidity and mortality, I found a stunning increase in the number of reportable events, spiking from an average of 226 reportable events a year (2016-2019) to 4,059 reports in 2022," she explained.

A DOD reportable event is any patient safety event resulting in death, permanent harm, or severe temporary harm—and all require a comprehensive systematic analysis and a follow-on corrective action implementation plan report.

"The point is there is a statistically significant increase in death, permanent harm, or severe temporary harm in young healthy fit pilots," she continued.

Such injuries were more obviously shown in this population. Because aviation pilots are required to have a superior level of health and fitness, and their health conditions are under more strict monitoring, according to Long.



What spurred Long on to pull this second round of data was when she learned the Federal Aviation Administration (FAA) had quietly <u>made changes</u> to the acceptable parameters of PR intervals (representative of the first part of a heartbeat, measured in seconds or milliseconds) on electrocardiograms of pilots. The FAA didn't respond with research and data to support their decision, according to Long.

Those actions led to the press release dated Jan. 27, 2023 from Johnson in <u>a letter</u> to the FAA, where he stated the following details:

"Based on data from the Defense Medical Epidemiology Database, the whistleblower [Theresa Long] reported that the total number of disease and injuries [reportable events] in pilots across the DOD was 265 in 2016, 252 in 2017, 164 in 2018, 223 in 2019, 2,194 in 2020, 2,861 in 2021, and 4,059 in 2022."

Johnson also told The Epoch Times these statistics "raise questions as to whether FAA has seen similar increases in disease and injuries in individuals in the aviation industry."

Long noted that in the "post-glitch" DMED, the number of reportable events across the DOD had gone from a four-year average (2016-2019) of 40,813 to 110,000 in 2020 to over 200,000 in 2022.

"Some would ask why the numbers start increasing in 2020, you have to remember the Pfizer/DOD study with 43,448 participants started on July 27, 2020."

Long emphasized that her opinions do not reflect those of the Army or the DOD.

Looking back, she said it was after being stonewalled for answers regarding adverse events from the COVID vaccine that she began performing queries in the DMED. She wanted to know if what she was seeing within her brigade were isolated anomalies or part of a wider disaster unfolding.

Whistleblowers First Report Discrepancies in DOD Data

It was in January of 2022 when Long, along with two other U.S. military doctors, Dr. Samuel Sigoloff and Special Forces flight surgeon Lt. Col. Peter Chambers, and Army Public Health Officer 1 Lt. Mark Bashaw first blew the whistle on the DOD. Together, they filed the initial whistleblower complaints regarding the

DMED data, which showed an inordinate amount of negative health-related conditions related to the vaccine.

The <u>initial DMED data</u> given to Johnson showed a massive rise in cases of anxiety, esophageal cancer, breast cancer, female infertility, miscarriages, HIV, acute myocarditis, and Bell's palsy among other conditions after the vaccine was mandated for U.S. military members.

Long added that after the DMED data was presented, Moderna, the pharmaceutical and biotechnology company behind one of the COVID-19 vaccinations and its mRNA immune response technology, lost \$140 billion of dollars in stock.

Yet, despite the alarming data coming directly from the DOD's own \$42 million medical surveillance database, the department's official claimed that the discovery of the data was a "data glitch" and proceeded to take the database offline, supposedly "fixing" it.

As <u>reported in The Epoch Times</u>, the DOD claimed that the data in DMED was incorrect for the years 2016-2020, but the 2021 number was not affected. The corrected data saw the data for prior years increased, which made the 2021 data look normal.

After Long handed over the documents to DOD, it took officials 47 days to formulate a response to the data, only to explain it was a surprise to them.

Based on the previous DOD data, "the cluster of medical conditions represents a dramatic shift in the acuity of medical conditions we normally see," said Long, noting that the data is "so catastrophic," at the very least when those numbers came out, the military would reflexively pause everything and investigate.

"They didn't pause anything and it took them [the DOD] a month to complete their sham investigation." She said. "It's a gross indictment and dereliction of duty."

"We introduce a brand new drug into our very healthy population and the surveillance people aren't even paying attention to their own \$42 million-a-year system?" asked Long, who noted that during her 30 years in the Army, many of which she served as a doctor, she and other colleagues never heard of such a database provided by the system's contractor Ussiant until 2019. "Don't you think introducing a drug that was rushed to an entire fighting force would make it a top priority that the surveillance system is working?"

Long also asked why, if the DMED just had a "glitch" during the COVID pandemic, no one is being held accountable for this egregious medical surveillance system failure. Long's attorney, Todd Callender, noted the DOD failed to produce a single expert IT witness that would testify under oath that the shocking data was just a "glitch."

"So if the data was that alarming, why didn't anyone in the Defense Health Agency (DHA) sound the alarm or catch the 'glitch,'" she continued. "How did they not see this huge spike in serious medical problems?"

Another question arises as to why military doctors like Long have not received any communication regarding this spike in reportable events, which wasn't just limited to pilots but also general officers and those in the Special Forces.

"I was notified to comb over our inventory after a risk management alert notification alerted me to two defective earplugs found at Fort Sill, Okla." Long said, "But I can't even get them to send out an alert saying 'Hey your pilots might get myocarditis from the vaccine."

For this story, The Epoch Times reached out for comment from Director of Defense Lloyd J. Austin, the Office of the Surgeon General, and the U.S. Department of Health and Human Services for comment.

'I Can't Un-see the Things I've Seen'

These new developments come as more physicians and patients have spoken out about a growing number of vaccine injuries while the science and research literature has simultaneously validated their claims and concerns.

Long said she was not only ignored but received threats against her career after speaking up. That's because no action was taken on the part of military leaders to fully investigate the number and scope of adverse medical events that she, Sigoloff, Chambers, and Bashaw initially brought to their attention.

"When I found the DOD data, they pulled my credentials and took all my patients off my schedule," said Long, noting that only left her more time to thoroughly look into the data.

While Long continues to add to her count of personally witnessed vaccine injuries, she also waits for a response from government officials with her latest filing.

Since she first came forward, she has also given testimony to the Idaho Legislature and at the Alaska Medical Freedom Symposium. Appearing recently on Fox News' Tucker Carlson Tonight, she spoke about the FAA's change in health requirements that significantly broaden the electrocardiogram range for pilots and allows those with cardiac injury damage to fly.

"In the light of emerging and overwhelming data showing cardiac damage from COVID and COVID vaccines on cardiac muscle, I can't imagine why they would make this move and I think it's a question that really should be taken to Dr. Susan Northrup, senior flight surgeon for the FAA," Long told Carlson.

Airline Pilot Deaths Revisited; They Are Still Dying Younger


Claims continue to circulate on the internet that airline pilot deaths have increased exponentially since the covid injection was mandated in early 2021. My investigation of the airline pilot deaths that appeared in the *Air Line Pilot Magazine* published by the Airline Pilots Association ("ALPA") since January of 2019 shows a 2.3% increase in pilot deaths in 2021 over 2020. There was a slight insignificant increase, certainly not exponential.

What is significant was the 40% rise in the incidence of pilots dying prior to the normal retirement age of 65. This increase happened in the year 2021. Until proven otherwise, the mandated covid injection is the cause.


The false claims of exponential rises in pilot deaths come from the way the deaths are reported in the ALPA magazine. They are not cumulative. And they are significantly delayed. The magazine is a monthly publication that has a section called 'In Memoriam. These are pilot deaths that the families of the deceased have decided to make public in honour of their deceased. For example, in the April 2023 issue, there was one death reported that occurred in May of 2019, and one reported that occurred in September of 2021. Eight were reported for 2022 and dozens through March of 2023. This makes it look like deaths are exponentially increasing. Actually, there were 464 deaths reported in 2019, 479 in 2020, and 490 in 2021.

Admittedly, the deaths reported in the ALPA magazine are a small subset of what is happening industry-wide. The magazine will only report the deaths for pilots that belonged to the Airline Pilot Association union. There are some large airlines whose pilots do not belong to ALPA, including American and Southwest. A more accurate method of gathering data would be to take the pilot seniority lists from all airlines and compare the lists from November of 2020 to the most recent seniority lists. This would take a tremendous amount of work as many of the pilots who disappeared from the lists may have retired, quit, or even moved on to a different airline. An obituary would be needed to verify the pilot died and at what age. Just going through these steps with the reported deaths in the ALPA magazine since January of 2019 through the present took hundreds of hours. I have the Excel file with links to the obituaries available to anyone who would like to see it. A few obituaries were not able to be verified as being the pilot named in the magazine.

The extrapolated Excel data shows an increase in younger pilot deaths starting in 2021:



The data also shows the average age of pilot deaths is decreasing over time:



I previously wrote a three-part Substack on pilot deaths titled 'An objective analysis of commercial airline pilot deaths as reported in the Airline Pilots Association (ALPA) magazine since 2019'.

<u>Part Two</u> described the physiological reasons why the covid injections could be a causative factor in pilots dying younger. Since that time, it has become even more apparent that the chance of a sudden unexpected death increases significantly with booster injections. As described in Part Two in detail, a simple explanation could be activation of the complement cascade, a very aggressive membrane attack complex that is antibody-dependent. Put another way, it takes the first injection to stimulate antibody production. The booster injection can cause the previously created antibodies and the memory to quickly remake them to overreact to the billions of spike proteins that will arise from subsequent shots. This can result in a membrane attack complex that is very destructive, particularly in the heart muscle.

Another mechanism was proposed by Steven Hatfill, MD, in the summer of 2022. He found that the mRNA in the covid injections codes for the spike protein to be in what is called an open configuration. When T-cells interact with

the spike protein that will be expressed on the surface of cells in this open configuration, it causes the T-cells to release highly inflammatory cytokines. This can start an escalating feedback loop that attracts even more white blood cells, resulting in more inflammation in the cardiac tissues resulting in myocarditis. <u>HERE</u> is the link.

Another mechanism was published by Yonker, et al, in January of 2023. <u>HERE</u> is the link. They compared vaccinated subjects that had myocarditis vs. those who did not have myocarditis. Those with myocarditis had free floating spike proteins circulating in their bloodstreams, whereas those without myocarditis did not have the circulating spike proteins. They do not explain why some have free spike proteins and others do not, they only report the findings. A possible explanation could be that with repeated booster injections, elevation of IgG4 antibodies occurs in some people. This reduces the ability of antibodies to bind to the spike proteins, allowing them to freely float. See HERE.

It took about two years for scientists to discover these unforeseen physiological mechanisms that explain what they expected to occur before mRNA covid-19 "vaccines" were introduced into billions of humans and thousands of pilots. Two years should have been the minimum amount of time dedicated to the safety and efficacy trials that only lasted a few months.

At the time these injections were mandated and forced into airline pilots, they were experimental, and still are experimental. The Federal Aviation Administration ("FAA") guidelines prohibit the use of experimental drugs in pilots. Even after a drug is Food and Drug Administration ("FDA") approved, the guidelines do not allow pilots to use the drug until a full year has passed. This allows time to identify any adverse reactions in the general population that might affect the safety of flight.

It can be weakly argued that the injection is not a drug, but a "vaccine." However, the guidelines for vaccines state that vaccines must be FDA approved. None of the injections were FDA approved when they started going into pilots in December of 2020. Pfizer got FDA approval to make Comirnaty on 23 August 2021. Moderna got FDA approval to make Spikevax on 31 January 2022. Spikevax was not in the marketplace until 1 April 2022. Comirnaty was not available until 18 May 2022, a year and a half after the mandate.

Pfizer's BNT162b2 injection got emergency use authorisation on 11 December 2020. The very next day, the FAA stated that it was safe for commercial airline pilots to get the injection. This decision was based on the belief that the FDA and the Centres for Disease Control ("CDC") had rigorously tested the inejction to prove it was safe and effective. The vaccine manufacturers set up the trials and the tests, not the FDA, not the CDC. The manufacturers compile the results, supposedly overseen by a third party. The results are then pitched to the advisory committees for the FDA and the CDC. The Vaccine and Related Biological Products Advisory Committee ("VRBPAC") advises the FDA. The Advisory Committee on Immunisation Practices ("ACIP") advises the CDC. Some members of these committees have ties to the pharmaceutical industry. Yet they say there is no conflict of interest.

None of the shots were safe for pilots. A known adverse event of special interest ("AESI") is myocarditis. In fact, the Summary Basis for Regulatory Action ("SBRA") for Comirnaty requires Pfizer to track and document myocarditis with various reports at specific times due until the year 2027. An SBRA is a document that provides a comprehensive summary of the scientific and clinical data submitted to a regulatory authority – such as the FDA – for a new drug, biologic, or medical device. It serves as a basis for regulatory action, including approval or denial of the product. HERE is a link to the document where you can word search "myocarditis."

The document also requires reports on subclinical myocarditis. Subclinical means asymptomatic, implying that the pilot could have myocarditis without knowing it. Since subclinical myocarditis can result in sudden heart failure without warning, the possibility of two pilots with subclinical myocarditis being in command of a passenger aircraft at the same time is real and potentially dangerous.

I am working with <u>US Freedom Flyers</u> to encourage the FAA to prohibit any further mRNA injections and to take steps to screen pilots for possible subclinical myocarditis.

Track Star Dies After Collapsing During Practice - Day Before, He Did Something Amazing

One day after breaking a personal record, a high school athlete from Nebraska died suddenly.

Hunter Palter, 18, who was a senior at Wisner-Pilger High School collapsed May 5 and died later that day, according to the U.K. Daily Mail.

"It is with a very heavy heart that we can confirm that Hunter Palmer, senior at Wisner-Pilger Schools, has died," the school said in a statement.

"It is important for parents to check in on their children during this difficult time. Grief is very complicated and can affect each child differently," the school posted.

The day before he died, Palmer competed in two events at a track meet.

He cleared a personal best of 6 feet 1 inch in the high jump to win the event, according to the <u>Omaha World-Herald</u>.

Palmer was also the third-lap <u>runner</u> in his high school's 1,600-meter relay team, which finished second.

Palmer also played basketball for his high school and was an all-district running back in football

According to the <u>Wayne Daily News</u>, Palmer collapsed during a <u>track practice</u> on the day he died.

Palmer had planned to attend Midland University in the fall.

Midland coach Jeff Jamrog posted a tribute to Palmer on Twitter.

"Yesterday heaven gained a great young man. Our hearts are heavy and we are all suffering with the pain of the loss of Hunter Palmer," the statement said.



National Champion Waterskier with 'Full Throttle Approach to Life' Dies Suddenly at 18

A student-athlete at the University of Louisiana at Lafayette died "suddenly" at the age of 18 two weeks ago, according to statements from his school, his team in his native country of Canada and his heartbroken family.

According to his **obituary**, Michael Arthur "Micky" Geller had recently completed his first year as a member of **the school's** Ragin' Cajuns Waterski Team.

On May 6, Geller died, but no cause of death has been released.

Water Ski Canada said on <u>Facebook</u> that Geller's death devastated those who knew him and took everyone by surprise.

"It is with heavy hearts and great sadness that we share with all of you the news that Micky Geller, from Ontario, has died suddenly," the team said.

Water Ski Canada added, "Micky was a valued member of the University of Louisiana at Lafayette Water Ski Team, and the Ontario skiing community and he represented Water Ski Canada on many occasions including the U17 IWWF World Championships, the Jr. US Masters Water Ski Tournament, and the 2022 Pan American Championships."

In addition to having been a talented **<u>skier</u>**, Geller had a passion for life that his family described as "full throttle."

"With his full throttle approach to life, Micky experienced more in his 18 years than many ever will," his family said. "However, he was just cracking the surface of the possibilities that lay ahead."

Prior to finding his niche as a skier, Geller also tried his hand at gymnastics in his younger years and was also into **motorcycles**, rock climbing and other outdoor activities.

His family remembered him as a young man who was known for "having deep conversations and debates and just chillin'."

The family added, "Our boy will be remembered for his empathy, passion, strength, fearlessness, drive, discipline and limitless potential."

Geller is survived by his parents and one sister.

He will forever be remembered as helping the university bring home its ninth waterski national championship last fall.

In mourning his loss, his team announced flags at the school were lowered to half-staff on Thursday.

"Micky was a freshman kinesiology major from Carp, Ontario, Canada, and was a member of the National Championship Ragin' Cajuns Waterski Team," the school said in a statement.

London Mayor Khan Left 'Barely Conscious' Due To Heart Attack Suffered Days After Receiving Covid Booster

Incident was kept quiet for nearly two years

London Mayor Sadiq Khan revealed in his new book, *Breathe*, he suffered a heart attack during the 2021 COP26 climate conference in Glasgow, Scotland.

Khan explained as he spoke to the COP26 crowd, "out of nowhere, I felt a knot in my chest – a kind of tightening" and he had to be "carried off the stage" while "barely conscious."

The book stated, "My shirt was drenched with sweat and I felt like I was on fire."

According to **the Evening Standard**, "It is not known what caused Mr. Khan to suddenly fall ill in Glasgow on November 10, 2021. But medical experts have confirmed that the symptoms and aftermath were consistent with a minor heart attack."

"Mr. Khan spent about seven hours overnight in A&E at Glasgow Royal Infirmary and underwent an electrocardiogram (ECG), which checks the heart's rhythm and electrical activity, a chest X-ray and several rounds of blood tests."

After learning he had suffered a minor heart attack, the then-51-year-old London mayor wrote in his book, "I couldn't believe it. I felt fine. I simply didn't believe I had had a heart attack. The whole situation felt unreal. In a matter of hours, I was due to give perhaps the biggest address of my mayoralty."

It's worth noting Khan received his first dose of a Covid jab in February 2021 and his booster shot on October 29, 2021, on the same day he got a flu vaccine.

Just twelve days after taking both a Covid booster and flu shot on the same day, Khan suffered the heart attack.

It's likely the health scare was kept from the public until now as it would have surely created more skepticism of the experimental mRNA jabs.

At the time he got his booster shot, Khan encouraged his fellow Londoners to do the same.

He said, "I want to be very clear to all Londoners. This deadly virus has not gone away and this winter we're facing both flu and Covid. The worst thing we can do is to lower our guard, be complacent and underestimate the risk these viruses pose to all of us."

16-Year-Old Alexandria High School Student Dies Suddenly at Home Jim Hoft May 7, 2023

A freshman at Alexandria City High School was found dead in his room on Tuesday morning, and his family is still looking for answers about what happened.

Yonatan Vazquez Méndez, 16, was found lifeless in his bedroom by his father, one day after they all had a birthday party.

"I saw him lying on the floor. I ran and hugged him," Vazquez Méndez's father, Daniel Vasquez, told Telemundo44.

The teen's parents have stated they had no clue what caused their son's death.

According to NBC News, they had a birthday party for Mendez's mom just the night before he died.

"I don't understand what happened to my son because he had a life with many plans for him. I don't even know what to say because he was a very obedient child," the teen's mother, María Anabel Méndez, said.

The cause of death of Yonatan Vazquez Méndez is under investigation.

A <u>GoFundMe</u> was created for the Vazquez Mendez family that had raised almost \$6,000 as of Sunday, May 7.

"Yonathan was a son, brother, cousin, nephew, friend, and most importantly a child of God," the fundraising page reads.

"He dedicated his time and life to Jesus Christ alongside his family and played the guitar in his congregation. During his free time he loved spending time with his family watching movies, play video games, while eating pizza and drinking his Starbucks. We ask during this difficult time that you pray for our family and we appreciate whatever amount God places in your heart, we thank you very much. God bless you!"

In an email obtained by **Daily Voice**, ACHS Principal Peter Balas broke the news of Yonatan's terrible death to the school community.

"Yonatan has been part of the Alexandria City Public Schools (ACPS) family since he was in middle school, and his passing is a sad and tragic loss for his family, friends and our school community.

"He was always respectful and was well liked by his peers. On behalf of the entire Titan community, we send our thoughts and prayers to his family and loved ones."

The family's apartment was crowded Thursday with relatives who drove from Texas when they got the tragic news.

"I still can't believe it because one day we had him with us and the other day we didn't," said Yonatan's cousin Sindi Méndez.

His cousins said they saw Yonatan as a brother.

"He was very humble, sweet, kind, smart, energetic. He was, he was the type of person that ... like, he was always there for you," cousin Chris Depaz said.

Music was Yonatan's passion and something he'd hoped to pursue as a profession, his family said. He played guitar for their church's band every Sunday.

His parents said Yonatan had an important role in their family looking out for his two younger siblings and using his English language skills to help take care of the bills and other household business.

Alexandria police said they're investigating the circumstances of the teen's death and whether it had anything to do with opioids. They are awaiting a report from the medical examiner.

The family, however, said they've never seen any indication their son had tried drugs.

"I had a meeting with the counselor, and he said that they had never seen anything with Yonatan, and he told me, 'Really, I congratulate you for being vigilant because not all mothers are like you," María Anabel Méndez said.

15-Year-Old Western Michigan High School Athlete Dies Suddenly After Medical Emergency


Pfizer is killing Children for Profit: Europe suffers unprecedented loss of lives among its Children with 760% increase in Excess Deaths since **EMA's Emergency Approval of COVID Vaccine for Kids**

It was the summer of 2021 when the European Medicines Agency (EMA) approved the use of the Pfizer COVID-19 vaccine for children aged 12 to 15. The decision was met with unjustified excitement and relief by many parents who had been eagerly waiting for a vaccine for their children.

However, soon after the vaccine rollout for children began, a shocking rise in excess deaths among children was reported across Europe.

And sadly, there has been a 760% increase in excess deaths among children aged 0 to 14 as of week 12, 2023.



COVID-19 vaccines were still in the early stages of development and had not yet completed the full regulatory approval process by the end of 2020.

In order to make the vaccines available as quickly as possible, regulatory agencies such as the European Medicines Agency (EMA) and the U.S. Food and Drug Administration (FDA) issued emergency use authorizations (EUAs) for the vaccines.

An EUA is a regulatory mechanism that allows the use of a medical product in an emergency situation, such as a pandemic before it has completed the full regulatory approval process.

One of the main reasons why mRNA vaccines had not been used on a large scale in the general population prior to December 2020 was due to Antibody-Dependent Enhancement (ADE).

ADE is a phenomenon where a previous infection or vaccination can lead to a more severe form of the disease upon subsequent exposure. In the case of COVID-19, there were concerns that vaccination with an mRNA vaccine could trigger ADE and make the disease worse in people who were vaccinated.



One example of ADE occurred during the development of a vaccine for dengue fever. In clinical trials, the vaccine appeared to provide protection against the virus in people who had not been previously infected. However, in people who had previously been infected with a different strain of the virus, the vaccine appeared to increase the risk of severe disease.

This has been the case in many animal studies, with potential "vaccines" causing lung inflammation or other adverse effects when the animals were later exposed to the virus. This is thought to occur because the vaccine-induced immune response is not effective in neutralizing the virus, and instead causes damage to the lung tissue.

Vaccine-Associated Enhanced Disease (VAED) has also been observed in some vaccine trials for respiratory viruses, including coronavirus.

For example, in clinical trials for a vaccine for RSV, some infants who were vaccinated experienced an increased risk of hospitalization and more severe respiratory illness when they later contracted the virus.

It is believed that the vaccine-induced immune response did not effectively protect against the virus and instead led to an overreaction of the immune system that worsened the symptoms of the disease.


Respiratory viruses, such as coronaviruses and RSV, were known to cause severe illness in vulnerable populations such as infants and the elderly.

But the alleged SARS-CoV-2 virus that causes COVID-19 is an exception and has little to no effect on children.

This of course leads to questions as to how medicine regulators around the world could possibly extend the Emergency Use Authorization (EUA) of the Covid-19 injections to children when there was no emergency when it came to children.

It certainly wasn't to prevent the spread of the virus because as we can see from real-world data, the Covid-19 vaccinated population are actually more likely to become infected and transmit Covid-19 than the unvaccinated population.



The figures showed that the case rates were highest among the triple vaccinated in all age groups. But not just by a little bit, instead by a million miles. And the gap between the unvaccinated and triple vaccinated had been getting worse by the month.

Therefore, these figures indicate the Covid-19 injections make recipients more likely to be infected with Covid-19 than the unvaccinated population.


Now, a new analysis of <u>data from across Europe</u> has sadly found a concerning link between the approval of the Pfizer COVID-19 vaccine for children and an increase in excess deaths among children.

The data has been provided to an organization called <u>EuroMOMO</u> by the relevant official statistical departments of each country in Europe. The data we analyzed covered up to week 12 2023 and had been gathered from 27 participating countries across Europe.

For context, there are actually 44 countries in Europe and the latest data does <u>not</u> include deaths in Ukraine. Therefore, the ongoing war cannot be blamed for what we found.

In week 21 of 2021, the European Medicines Agency (EMA) extended emergency use authorization of the Pfizer COVID-19 vaccine to children aged 12 to 15, and a few months later extended it to 5 to 11-year-olds.




But in the weeks following the approval, a shocking rise in excess deaths among children was reported. And the rise in excess deaths has continued ever since.

Between week 22 of 2021 and week 52 of 2021, there were 754 excess deaths among 0 to 14-year-old children.




In contrast, between week 1 and week 21 of 2021, there were 309 fewer deaths than expected. The increase in excess deaths correlates perfectly with the EMA's approval of the Pfizer COVID-19 vaccine for children aged 12 to 15.




Sadly the increase in deaths among children continued between week 1 and week 52 of 2022. The data shows that there were 1,358 excess deaths among children aged 0 to 14 across 27 countries in Europe.




And as of week 12 of 2023, there have been 336 excess deaths, bringing the total number of excess deaths to 2,448 during the 95 weeks following the EMA's Emergency Use Approval of the Covid-19 vaccine for children.








Minus-422 excess deaths throughout the entirety of 2020.




And then minus-309 excess deaths between weeks 1 and week 21 of 2021.








A vaccine that was still in the early stages of development.

His wife, Charlotte Wright, is trying to get the cause of death changed from "natural causes" on his death certificate. She has also filed a lawsuit against the pharmaceutical company and dozens of people.

Senior Coroner Andrew Harris explained in a court hearing that Wright's death was caused by a brainstem infarction, bleed on the brain, and "vaccine-induced thrombosis."

"Dr. Wright was a fit and healthy man who had the AstraZeneca covid vaccination on 16 January 2021, awoke with a headache on the 25th and later developed left arm numbness," Harris testified at London Inner South Coroner's Court, according to a report from the BBC. "He attended an emergency department just after midnight, where he was found to have high blood pressure and a sagittal sinus venous thrombosis."

"He was transferred to King's College Hospital at 6:39 am but, because of the extent of the bleed and very low platelets, was unfit for surgery, dying at 6:33 pm," the coroner added. "My conclusion as to the cause of death is unintended complications of vaccination."

"Mrs Wright, who was on maternity leave when her husband died, said that before she received £120,000 from the government's Vaccine Damage Payment Scheme (VDPS) in August, she had used food banks to help support her children, now aged nine and three," the BBC report states.

The company's spokesperson told the BBC that "the benefits of vaccination outweigh the risks of extremely rare potential side effects."

The spokesperson also offered their "deepest sympathies" to Wright's family.

"We are very saddened by Stephen Wright's death and extend our deepest sympathies to his family for their loss. Patient safety is our highest priority and regulatory authorities have clear and stringent standards to ensure the safe use of all medicines, including vaccines."

Tragedy as healthy young man, 29, dies suddenly just months before his wedding

'Fit and healthy' Robert Golding was just 29 and weeks away from walking down the aisle when he died suddenly of sudden unexplained cardiac arrest, leaving family and loved ones devastated

A "fit and healthy" man in his twenties died just months before his <u>wedding</u> leaving his family shellshocked and heartbroken.

Robert Golding, 29, died of unexplained cardiac arrest, with his devastated family now speaking out about their "mountain of unanswerable questions".

Siblings of Mr Golding - who was 12 weeks away from marrying his fiancée - have recounted the "worst moment" of their lives when they received the call to say their beloved brother had passed away in February 2021.

The family waited four months to find out Robert, from Salford, Manchester, died from sudden arrhythmic death syndrome (SADS), a sudden and unexplained <u>cardiac arrest</u> that proved fatal.

Robert has since been described as "always happy and cheerful" and someone who "made people fall in love with him for just being there".

Robert's sister, Nicola Walsh, said the sudden death of her younger brother "with no real explanation" had left their family and friends behind with an "unfillable void".

"The pain of losing a loved one to SADS is unimaginable," Ms Wardley told the Manchester Evening News.

"One day they are happy, and healthy, sending you boxset recommendations, and the next day they are gone with no real explanation.

"Losing Rob has left us with an unfillable void and a mountain of unanswerable questions that we must carry with us.

"He had his whole life to live - it didn't make sense to us, how could somebody that healthy disappear overnight? "You have to learn to live with the fact there should be no reason for them to be gone."

"His wedding was set for May 2021, and having to face that day - what should have been one of his happiest - without him, was cruel and difficult for us to come to terms with," the 36-year-old said.

Robert was described as the "one that made us laugh uncontrollably, made us look bad in front of our parents, and made people fall in love with him just for being there".

The family said they have continued over the last 14 months to adjust to the silence they have been left with. Nicola and sibling Chris Golding, 34, are now gearing up to run this weekend's **London Marathon** to raise money and awareness for the cardiac charity SADS UK in memory of their brother.

"We made a decision that everything we do in life is done for Robert. We get to continue to live for him - and what better way to celebrate that, than to complete the London Marathon," Nicola said.

The pair chose to support SADS UK which helps areas of education, research, prevention and resuscitation, and provides information about the condition.

The charity promotes the warning signs that when shown could indicate a person may be at risk, prompting them to seek medical advice and treatment if appropriate.

SADS UK also installs defibrillators in schools and widely in the community.

The family have raised a huge amount of almost £12,000 so far through various fundraising events.

"I have dedicated myself now to supporting SADS UK in the hope that nobody has to go through what we have been through.

"I run for Rob, and for all those who have been affected by sudden cardiac death. We are not alone, and we will live for those we have lost," she said.

Nicola admits that she has actively 'avoided running at all costs', but wanted to challenge herself and raise funds out of her usual comfort zones.

Family of Marquette student who died suddenly mourns his loss Tajma Hall April 20, 2023

MILWAUKEE (CBS 58) -- The family of a Marquette student is mourning his loss.

The Milwaukee County Medical Examiner's Office says it appears Kamrin Ray, 19, died of natural causes.

Ray was a Marquette freshman from Chicago was found dead inside his dorm room at Cobeen Hall on Monday.

Glenn Harston II is his uncle and says this loss has been devastating to the whole family.

"It was unbelievable. Literally, when they said it, I didn't hear it," he said. Harston says his nephew was like a son to him.

"Kam was a walking, talking oxymoron. Kam was softspoken but very outspoken...Kam was very funny but told horrible jokes. Kam was an introvert but loved being around people," his uncle said.

On April 17, Kamrin Ray was found unresponsive in his dorm room bed by his roommate.

Students say the campus is pretty shaken up. "I've seen him at the gym where I work, and I've said hello and he's the sweetest kid. I can't believe it. This is tragic for everyone at the school," said Jack Hartle, a Marquette sophomore.

According to the Milwaukee County medical examiner, there were no signs of trauma, foul play, no drugs at the scene, and Kamrin didn't have a history of drug use. "It's reported as a natural cause," said Harston.

Harston says his nephew was a diabetic but the family, as well as Kamrin's doctor, does not believe diabetes played any role in his death.

"He had diabetes very much under control. He was very in tune with his levels. Kam was in the best shape of his life," said Harston.

The medical examiner's office says the official cause of death is pending a toxicology report and further review.

21-Year-Old College Student Dies Suddenly - Suffered Cardiac Arrest During Soccer

Mercer University's Baba Agbaje, a 21-year-old student athlete on the Mercer Bears soccer team, passed away last week after suffering a heart attack during a game, according to the coroner for Macon-Bibb County in Georgia.

WGXA confirmed cardiac arrest as the cause of death Monday, citing coroner Leon Jones, but WXIA-TV, reporting the following day, no "official cause of death has yet been determined, as an autopsy has not yet been performed."

In all, deaths among professional football/soccer players in 2021 were 4 times the average rate recorded between 2009 and 2020.





The data shows that professional football/soccer players died of cardiovascular problems during games (match or training) at 4 times the average rate recorded between 2009 and 2020.


It also reveals that there were more than 15x as many deaths due to cardiovascular issues in 2021 than there were in 2020.

But what's most concerning is that there were 3.5 times as many deaths in December 2021 than there were in the whole of 2020, and there were almost as many deaths in December 2021 (7) as the annual average rate over the last 12 years (7.8 per year).

And the real problem is this...



Cardiovascular deaths among professional football/soccer players were doubling every quarter. So by the end of 2022, they may have risen to 320 per quarter (40, 80, 160, 320) but we no not have access to that data yet.

The advice given to footballers who collapse but survive is that they should cease all strenuous activity for 3 months. These figures reveal that all athletes who are Covid-19 vaccinated should do the same thing.

22-Year-Old National Guard Soldier Suffers Two Heart Attacks, Neurological Issues After Moderna Vax

A 22-year-old Army National Guard member has suffered an array of health issues—including two heart attacks that pushed her to the brink of death—after receiving two doses of the Moderna COVID-19 vaccine. Karolina Stancik once considered herself "very healthy," playing multiple sports from adolescence through early adulthood. At 21 years old, she chose to serve the country by joining the U.S. Army in February 2021. "We were told that it was going to be required and we should take it before we shipped out to basic training," she said, which was before Secretary of Defense Lloyd Austin's August 2021 announcement of the military vaccine mandate.

This messaging, according to Stancik, made the new recruits feel like, "You're a bad person if you don't get the vaccine, and you don't care about the people around you."

"As a young, new soldier, I and a lot of others around me, did what we were told," Stancik said.

"We were too new to know all the rules and possible loopholes," she added. "I pretty much blindly took it because I didn't know you could get exemptions" for medical or religious reasons.

Stancik ended up taking the Moderna vaccine in March and April 2021; since then, "life has been an uphill battle," she said.

First, came the breathing issues.

"I was dealing with what doctors considered asthma at the time without a diagnosis, and I had never had any lung issues at any other point in my life," she said.

Stancik also experienced what felt like a cold or sinus infection, pressure in her head, and dizziness.

Next came a fever, as well as numbness and tingling throughout her body. But she was told by a doctor that these symptoms were normal.

At one point, her command threatened to accuse her of insubordination for not participating in physical training. However, "a doctor's order kept me from getting in trouble with my command," she said. The Epoch Times viewed that order, as well as other medical documentation and Stancik's Army permanent medical profile, to corroborate her claims.

Problems with visual processing and what she described as neurological issues began in October 2021. These included numbness, tingling, stabbing pains throughout her body, loss of motor function, tremors, and more. "It all progressively got worse, and never stopped," Stancik said.

In October 2021, she found herself in an emergency room, following her first heart attack. Things only escalated after that as she started experiencing nausea, a high heart rate, stabbing pains, and blacking out, she said. In February 2022, she had a second heart attack.

In addition to these two heart attacks, Stancik said she's been diagnosed with severe asthma and postural orthostatic tachycardia syndrome (POTS), a blood circulation disorder that causes a higher heart rate when transitioning from sitting or lying down to standing up.

In November 2022, her doctor told her she had "signs of a mini-stroke," she said. After that incident and the onset of impaired eyesight, she was finally advised to see a neurologist. She's now waiting for the results of tests for neuropathy, dysautonomia, lupus, multiple sclerosis, and others.

Stancik's neurological problems have continued this year.

"As I wait for results about my neurological issues, I'm also experiencing increasing problems with my visual processing," she said.

With health issues on the rise, she said, "Half together is put together for me right now." Read more here...

Died suddenly, North Carolina Central basketball player Devin Butts, 22

North Carolina Central University basketball player Devin Butts died on Friday after collapsing earlier in the week while playing in the university's main gym, NCCU's athletic director said Sunday.

No cause of death has been reported.

NCCU Athletic Director Louis Perkins said Butts was at the campus's main gym playing basketball with several others when he collapsed and doctors are now trying to identify the cause.

"We are aware of no history that could cause this," Perkins said.

NCCU requires the Covid vaccination for "in-person student activities."

Butts was on track to graduate this summer with a bachelor's degree in behavioral and social sciences. He still had a year of eligibility to play, and planned to return to the NCCU squad for the next season.

"It's just so hard for me to even come to grips with right now," Perkins said. "Just playing basketball and fall out."

Stephen Fusi, NCCU's chief spokesperson, confirmed that Butts was taken to the hospital on April 30, and that the incident did not happen at a team event. There was no indication of foul play or suicide, he said.

NCCU men's basketball coach LeVelle Moton said in a news release that Butts "will always be remembered as an incredible teammate that had an infectious smile at all times. We're just mourning the loss of a really, really sharp, bright young man."

ESPN Director Dies Unexpectedly in Middle of NCAA Tournament

A longtime ESPN director and a former college baseball player died unexpectedly over the weekend while covering an NCAA tournament.

The network announced on Sunday that Kyle Brown died on Saturday at age 42 during its coverage of the NCAA baseball super regional in Winston Salem, North Carolina.

Brown suffered what ESPN called a "medical emergency" but no other information was made available.

His death was first announced on Twitter by golf commentator and podcaster Gary Williams.

"Kyle Brown died suddenly today," Williams posted on Saturday. "He was a lead producer for Morning Drive @GolfChannel."

Williams described Brown's death as "simply unimaginable."

"All of us who were fortunate to have him in our lives ask for prayers for the comfort and care of his wife and children. Our time is too precious for words," Williams said.

That event was postponed after Kealoha fell ill, according to the report.

Former NHL Player Dead of a Heart Attack at Age 38

Raymond Sawada, a former NHL player for the Dallas Stars, has died from a heart attack at the age of 38.

100 PERCENT FED UP — Sawada was a second-round pick (52nd overall) in the 2004 NHL draft. He played for the Dallas Stars in the 2008-09 season and, following his retirement from professional hockey in 2016, became a firefighter in British Columbia for the City of Burnaby.

On Monday, the young Canadian athlete was playing in a hockey game with the Richmond Cowboys when he suddenly suffered a heart attack.

Sawada left behind his wife and two young daughters, ages 9 and 6, whom he coached in hockey.

Just before the game, he had been celebrating the birthday of his 9-year-old daughter Victoria.

Sawada's death adds to a growing list of young athletes who unexpectedly suffered heart attacks and, in many cases, dropped dead.

In December, a 22-year-old Colombian professional soccer player named **Andres Balanta** who played for the Argentinian team Atlético Tucumán died suddenly after suffering a heart attack and collapsing during the team's first training session after their holiday break.

In January, a healthy young football star on the Air Force football team, **Hunter Brown**, died suddenly at the age of 21 from a blot clot in his lungs.

Also in January, a healthy 20-year-old soccer player named **Luke Abrahams** died suddenly, leaving his family, friends, and teammates devastated.

In a similar case just a month later, a perfectly healthy 23-year-old soccer player named **Michael Palmer** died unexpectedly after collapsing during a game.

In February, a 21-year-old football player from Jackson State named **Kaseem Vauls** suffered cardiac arrest and had to be resuscitated and placed on a ventilator.

Just six weeks prior, a 24-year-old NFL player **Damar Hamlin** stunned the nation after he went into cardiac arrest and collapsed on the field during a Monday Night Football game.

District Attorney Launches Investigation After Massachusetts Maritime Academy Cadet Found Dead in Dorm

A cadet at Massachusetts Maritime Academy was found dead in her room on Wednesday morning, Boston25 News <u>reported</u>.

Authorities have already launched an investigation.

According to Cape and Islands District Attorney Rob Galibois, a 22-year-old woman was found dead in her dorm room at the public university in Buzzards Bay shortly before 10 a.m.

Based on the preliminary investigation, there are no signs of foul play and no threat to public safety. DA Galibois is expected to release more information regarding the incident.

Academy President McDonald issued a statement following the incident.

"It is with a heavy heart and great sadness that I can confirm a cadet has passed away in our dorms. Until further details are available, we request that the privacy of the family be respected during this difficult time," said Academy President Rear Admiral Francis X. McDonald.

32-year-old psychologist died from 'unintended complications of the vaccine,' inquest reportedly ruled

Psychologist Stephen Wright of the U.K., who passed away in 2021 shortly after receiving the Oxford-AstraZeneca COVID-19 vaccine, died because of "unintended complications of the vaccine," an inquest ruled, according to <u>BBC News</u>.

Wright, who was only 32 years old, passed away a mere 10 days after getting a first shot, senior coroner Andrew Harris found, according to the report.

The psychologist had a blood clot to his brain post-vaccination, according to the outlet, which also noted that the man's widow, Charlotte Wright, has been seeking to have the "natural causes" terminology on the death certificate altered.

Harris characterized the situation as a "very unusual and deeply tragic case," the outlet reported. The man had a brainstem infarction, bleeding on his brain, as well as "vaccine-induced thrombosis," the inquest heard, according to BBC News.

Harris reportedly said it was "very important to record as fact that it is the AstraZeneca vaccine - but that is different from blaming AstraZeneca." He also reportedly noted, "It seems to me that there is not an action one can take at the moment."

In response to the findings of the coroner, an AstraZeneca spokesperson claimed that "the benefits of vaccination outweigh the risks of extremely rare potential side effects," BBC News reported. "We are very saddened by Stephen Wright's death and extend our deepest sympathies to his family for their loss. Patient safety is our highest priority and regulatory authorities have clear and stringent standards to ensure the safe use of all medicines, including vaccines."

"It was made clear that Stephen was [previously] fit and healthy and that his death was by vaccination of AstraZeneca," Wright's widow said, according to the outlet. "For us, it allows us to be able to continue our litigation against AstraZeneca. This is the written proof."

Pfizer is killing Children for Profit: Europe suffers unprecedented loss of lives among its Children with 760% increase in Excess Deaths since **EMA's Emergency Approval of COVID Vaccine for Kids**

THE EXPOSÉ APRIL 16, 2023

It was the summer of 2021 when the European Medicines Agency (EMA) approved the use of the Pfizer COVID-19 vaccine for children aged 12 to 15. The decision was met with unjustified excitement and relief by many parents who had been eagerly waiting for a vaccine for their children.

However, soon after the vaccine rollout for children began, a shocking rise in excess deaths among children was reported across Europe.

And sadly, there has been a 760% increase in excess deaths among children aged 0 to 14 as of week 12, 2023.



COVID-19 vaccines were still in the early stages of development and had not yet completed the full regulatory approval process by the end of 2020.

In order to make the vaccines available as quickly as possible, regulatory agencies such as the European Medicines Agency (EMA) and the U.S. Food and Drug Administration (FDA) issued emergency use authorizations (EUAs) for the vaccines.

An EUA is a regulatory mechanism that allows the use of a medical product in an emergency situation, such as a pandemic before it has completed the full regulatory approval process.

One of the main reasons why mRNA vaccines had not been used on a large scale in the general population prior to December 2020 was due to Antibody-Dependent Enhancement (ADE).

ADE is a phenomenon where a previous infection or vaccination can lead to a more severe form of the disease upon subsequent exposure. In the case of COVID-19, there were concerns that vaccination with an mRNA vaccine could trigger ADE and make the disease worse in people who were vaccinated.

One example of ADE occurred during the development of a vaccine for dengue fever. In clinical trials, the vaccine appeared to provide protection against the virus in people who had not been previously infected. However, in people who had previously been infected with a different strain of the virus, the vaccine appeared to increase the risk of severe disease.

This has been the case in many animal studies, with potential "vaccines" causing lung inflammation or other adverse effects when the animals were later exposed to the virus. This is thought to occur because the vaccine-induced immune response is not effective in neutralizing the virus, and instead causes damage to the lung tissue.

Vaccine-Associated Enhanced Disease (VAED) has also been observed in some vaccine trials for respiratory viruses, including coronavirus.

For example, in clinical trials for a vaccine for RSV, some infants who were vaccinated experienced an increased risk of hospitalization and more severe respiratory illness when they later contracted the virus.

It is believed that the vaccine-induced immune response did not effectively protect against the virus and instead led to an overreaction of the immune system that worsened the symptoms of the disease.


Respiratory viruses, such as coronaviruses and RSV, were known to cause severe illness in vulnerable populations such as infants and the elderly.


But the alleged SARS-CoV-2 virus that causes COVID-19 is an exception and has little to no effect on children.



Therefore, these figures indicate the Covid-19 injections make recipients more likely to be infected with Covid-19 than the unvaccinated population.

Now, a new analysis of <u>data from across Europe</u> has sadly found a concerning link between the approval of the Pfizer COVID-19 vaccine for children and an increase in excess deaths among children.

The data has been provided to an organization called <u>EuroMOMO</u> by the relevant official statistical departments of each country in Europe. The data we analyzed covered up to week 12 2023 and had been gathered from 27 participating countries across Europe.

For context, there are actually 44 countries in Europe and the latest data does <u>not</u> include deaths in Ukraine. Therefore, the ongoing war cannot be blamed for what we found.

In week 21 of 2021, the European Medicines Agency (EMA) extended emergency use authorization of the Pfizer COVID-19 vaccine to children aged 12 to 15, and a few months later extended it to 5 to 11-year-olds.




But in the weeks following the approval, a shocking rise in excess deaths among children was reported. And the rise in excess deaths has continued ever since.


Between week 22 of 2021 and week 52 of 2021, there were 754 excess deaths among 0 to 14-year-old children.


In contrast, between week 1 and week 21 of 2021, there were 309 fewer deaths than expected. The increase in excess deaths correlates perfectly with the EMA's approval of the Pfizer COVID-19 vaccine for children aged 12 to 15.







Sadly the increase in deaths among children continued between week 1 and week 52 of 2022. The data shows that there were 1,358 excess deaths among children aged 0 to 14 across 27 countries in Europe.



And as of week 12 of 2023, there have been 336 excess deaths, bringing the total number of excess deaths to 2,448 during the 95 weeks following the EMA's Emergency Use Approval of the Covid-19 vaccine for children.




This is a huge cause for concern because the previous 95 weeks from week 30 of 2019, to week 21 of 2021, saw 371 fewer deaths among children aged 0 to 14 than expected. With 360 excess deaths between weeks 30 and 52 of 2019.








This means excess deaths among children aged 0 to 14 across 27 countries across Europe, including the UK, Frane, Spain, Italy and most of Germany, have increased by 760% ever since the European Medicines Agency extended the emergency use authorisation of the Pfizer COVID-19 vaccine to children aged 12 to 15.





A vaccine that was still in the early stages of development.

A type of "vaccine" never before used in Humans due to the risk of antibody-dependent enhancement (ADE) and Vaccine-Associated Enhanced Disease (VAED).

And a vaccine that never needed to be administered to children because they were not at risk of suffering serious illness due to the alleged Covid-19 virus.
