Mrs. Tressel has 25 years of dutiful and honorable work associated with the Sweet Home School District. She has had no prior disciplines nor previous problems associated with her job. After 25 years with the district it can be assumed that her work and ethics have been exceptional and exemplary.

Mrs. Tressel cannot be legally forced to sign any documents for an exemption to the covid shot. Her reason(s) for not wanting the covid shot are no one's business other than her own. She has every constitutional and lawful right to refuse the covid shot.

As the last 1½ years have borne out since the covid shots were first administered, Mrs. Tressel made the correct decision not to introduce this experimental shot into her body. A recent study from Denmark has shown it increases your risk of contracting the covid variant/mutation "Omicron" and "Delta". (Attachments 1,2) Those not taking the covid shot had only a 3% incidence of Omicron infection, while those that did take the covid shot had an increasing incidence of Omicron infection with the initial covid shot and each subsequent one. In the United States, those states with the greatest percentage of their population "vaccinated" have had the greatest incidence of covid infection, especially the Delta and Omicron variants/mutations. (Attachment 3)

Second, the covid shot has been directly linked to significant and unacceptable morbidity and mortality in its recipients. Myocardial infarctions, myocarditis, thrombi, autoimmune disorders, cancer, neurological disorders, miscarriages, abnormal menstrual cycles, and many other medical problems have resulted from these experimental shots; and this is only the initial acute phase of the covid shot experiment. Chronic problems associated with the covid shots have yet to be determined. Your chance of death from the different covid shots is 169 times greater than an influenza shot. Look closely at the morbidity and mortality of the covid shots since December 2020 versus all other vaccines since 1990 - deaths are over five times greater in 1½ years with the covid shots than 32 years of all other vaccines combined. This information comes directly from the VAERS data on the CDC website. https://vaersanalysis.info/2022/04/29/vaers-summary-forcovid-19-vaccines-through-4-22-2022/. VAERS has always been assumed to contain only 10% of the actual morbidity and mortality associated with vaccines; the same is felt to be true with the EXPERIMENTAL covid shot. except in a handful of animal studies, the results of which were disastrous.

Medical data has demonstrated that covid shots do not stop the spread of covid. (Attachment 4) Additionally, the CDC's data shows masks do not stop the spread of covid. (Attachment 5)

The inventor of the mRNA shot, Dr. Malone, has stated repeatedly that this shot should not have been given to humans and that it will create "super spreaders". He has also stated, "The idea that if you have a workplace where everybody's vaccinated, you're not going to have virus spread is totally false. A total lie." Dr. Malone took two covid shots and has had chronic medical issues since. (Attachment 6)

Recent military data has shown skyrocketing morbidity and mortality associated with the experimental Covid shots. (Attachment 7,8) A just released German study from Professor Harald Matthes of Berlin's Charite University Hospital has demonstrated that "serious side effects" from Covid 19 shots are 40 times higher than previously reported. (Attachment 9,10)

Army military flight surgeon Lt. Col. Theresa Long stepped forward as a whistleblower declaring her medical concerns for pilots who received the covid shots and that they should not be allowed to fly without a period of medical observation and medical studies, because of the associated risk of a thrombus (clot) and myocarditis/pericarditis (heart inflammation). Dr. Peter Chambers, Dr. Samuel Sigoloff and Dr. Theresa Long, all military physicians, "reviewed DMED numbers that are technically medical billing codes for diseases, injuries, and diagnoses in military personnel. According to those codes, they said, a diagnosis for cancer jumped 300% and female infertility jumped 471%. Among other medical issues, miscarriages jumped 300% and even a diagnosis of Bell's palsy jumped 291%." (Attachment 8) These are but a handful of examples.

U.S. Army Lieutenant Colonel Paul Douglas Hague submitted his resignation paperwork, citing the military's vaccine mandate and what he called the "Marxist takeover of the military." (Attachment 12)

J.H. Lastly, Pfizer's own data was leaked and demonstrated 1,223 deaths worldwide, many within the first 24 hours, and over 100,000 associated illnesses/disorders in just the first 90 days. (Attachment 14) It is no wonder Pfizer doesn't want their data released for 75 years.

Tina Tressel has no obligation, nor is she contracted, to be forced to participate as a "guinea pig" in a worldwide experiment that has proved itself to be a disaster that will only get worse. The covid shots can only be described as a **genocide**.

Tina Tressel was not putting her students nor their families at risk for covid illness. It is now well documented that covid is not a problem for our youth. Of youth 0-18 years old who are infected with covid, the mortality rate is 0.003%. Therefore, there is no rational concern of Mrs. Tressel causing harm to these students. And of the 0.003% who did die, most had significant medical issues that put them at significant risk of mortality from any negative medical issue. (Attachment 15) Also, children are extremely unlikely, if at all, to infect adults at home. (Attachment 16)

It is extremely concerning how the Sweet Home School District and the Oregon Department of Justice (ODOJ) have so far handled Tina Tressel's case. A hearing had been scheduled for Mrs. Tressel on April 13, 2022, but instead it was deceptively turned into a board meeting. **This is psychologically and economically abusive.** Tina Tressel was in constant contact with the school board up until her scheduled hearing and was given no indication that her hearing would be postponed.
