Notice of Non-Recognition of the Oregon Board of Psychologist Examiners<sup>1</sup> as a Legitimate Judicial Authority

### Definitions as used:

**Special Appearance:** Appearance before an entity claiming to have judicial authority or jurisdiction over a person or class of persons for the sole purpose of asserting or arguing the non-legitimacy, lack of authority, and/or lack of jurisdiction over a person or class of persons. This in relation to a person or class or persons against whom allegations have been made, hearings are scheduled, and sanctions are proposed.

**Appearance:** In this matter, appearance is conservatively construed as any interaction between myself and the parties to whom I am sending this notice of non-recognition. This includes any and all correspondence of which there is proof and record of delivery and receipt. This, no matter whether the communications are at the time of a scheduled hearing, before the time of a scheduled hearing, and/or after the time of a scheduled hearing.

**Non-recognition:** Refusing or declining to honor as legitimate, a person or organization's right to exist in the manner they purport to exist. Refusing or declining to honor as legitimate the authority or jurisdiction of a person or organization to engage in certain activities or functions. Asserting that said person(s) or organization(s), beyond

opinion, are factually and by law <sup>2</sup> not legitimate in their claims to authority and/or jurisdiction.

**State agency:** An agency, bureau, commission, or similar group which is granted a right to exist as an agent of the state in a manner articulated effectively and legally in statute provided the statute is congruent with superior law and meets the criteria for state agency as set forth in *State Bd. of Dental Examiners v. FTC*, 135 S. Ct. 1101, 574 U.S., 191 L. Ed. 2d 35 (2015) and *Cal. Retail Liquor Dealers Ass'n v. Midcal Aluminum, Inc.*, 445 U.S. 91 (Supreme Court 1980).

### **Declaration:**

I, Christian Wolff, do not recognize the legitimacy or legality of the Oregon Board of Psychologist Examiners' (OBPE) existence. I do not recognize OBPE's authority or jurisdiction to pass any judgement upon me or to impose any sanctions against me.

I do not recognize the legitimacy, legality, authority, jurisdiction, or purpose of the Oregon Office of Administrative Hearings (OAH).

Nothing that I say, write or do <sup>3</sup> shall be construed as recognition, or even default recognition, of the authority or jurisdiction of OBPE or OAH to pass judgment on me, impose sanctions upon me, or to compel me to act in any manner.

In as much as I am engaged in ongoing disputes with OBPE and other regulatory boards, any reference, by me, to the action OBPE or OAH proposes to take in their case against me personally shall be regarded as incidental and part of arguments surrounding a greater dispute.

Nothing that I say, write or do <sup>4</sup> shall be construed as a plea, motion, argument, or other legal maneuver designed to gain a more favorable outcome in an OBPE, OAH, or OBPE/OAH tribunal or to gain their *noblesse oblige*.

Negation of this declaration by OBPE or OAH shall not be recognized in that neither, by this declaration of fact, are being recognized as having legal and legitimate authority or jurisdiction to negate this declaration.

I, Christian Wolff reserve the right, under this declaration, to engage public entities without defaulting to Regular Appearance. Special Appearance status shall be
